# CALL FOR PROPOSALS BY GARDENING COMPANIES FOR THE LANDSCAPING SERVICES FOR THE RESIDENCE OF THIS EMBASSY OF ITALY

The Embassy of Italy in Washington, D.C. issued a call for proposals by gardening companies to provide landscaping services at the Residence of this Embassy. The contract will start January 1<sup>st</sup>, 2023 and end December 31<sup>st</sup>, 2023.

## **Recipients**

This call for proposals is aimed to gardening companies that meet the requirements described above, and that have the expertise, and the technical and management resources to enter such agreement.

## **Purpose**

This call for proposals is aimed to start a constructive dialogue with all interested gardening Companies. At this stage, statements of interest submitted with the requested data will not be considered as binding for the Embassy Administration. Gardening Companies that submit statements of interests will not gain preferred placement position in the decision making process of the Embassy Administration.

### Requirements

As a guarantee of sound business practices in the field of landscaping, in the statement of interest companies must include the following documentation:

- Authorization issued by the competent U.S. local authorities to operate;
- Professional capabilities and sound business practice in the landscaping field in the United States:
- Financial statements and business plan.

### **How to Submit a Statement of Interest**

The statement of interest, together with the required documentation outlined above and with the attached form (annex 1) fully completed, must be received in an envelope, sealed and countersigned on the closing flaps, by courier or other means, no later than 2pm on November 2<sup>nd</sup>, 2022 at the following address:
