CALL FOR PROPOSALS BY COMPANIES FOR THE ADJUDICATION OF DIGITALIZAZION SERVICES FOR THE CONSULAR ARCHIVES OF THE EMBASSY OF ITALY IN WASHINGTON

The Embassy of Italy in Washington, D.C. issues a call for proposals to select a company, through a bid process, for the digitalization service of the consular archive with 12.000 files.

Recipients

This call for proposals is aimed to companies that meet the requirements described above, and that have the expertise, and the technical and management resources to enter such agreement.

Purpose

This call for proposals is aimed to start a constructive dialogue with all interested insurance companies. At this stage, statements of interest submitted with the requested data will not be considered as binding for the Embassy Administration. Companies that submit statements of interests will not gain preferred placement position in the decision making process of the Embassy Administration.

Requirements

As a guarantee of sound business practices in the field of the services rquired, in the statement of interest companies must include the following documentation:

- Membership in professional organizations based on the company's expertise and qualifications, and authorization issued by the competent U.S. local authorities to operate;
- Professional capabilities and sound business practice in the field in the United States:
- Financial statements and business plan.

How to Submit a Statement of Interest

The statement of interest together with the documentation outlined above and the attached form (annex 1) fully completed, must be received in a sealed envelope, by courier or other means, no later than 2pm Wednesday February 1st at the following address:
